Minutes of Poslingford Parish Council Meeting

Date 10th January 2024, 18:30 Meeting held at Stansfield Village Hall

Attendees: Parish Councillors Martin England, Marc Allison, June Mansfield, Kathy Priestley and Rachel Stebbing. County Councillor: Bobby Bennett District Councillors: Nick Clarke Chris Turner (Clerk to the Council)

The Chair, Martin England welcomed those present. Apologies received from Parish Councillor Annie Jones.

Parishioners Comments. No parishioners present.

County Councillor and District Councillors Reports.

County Councillor Bobby Bennett. Report received and can be accessed via web-site (https://poslingford.onesuffolk.net/). Difficult financial decisions need to be made. However, Highways budget will be protected since roads need pothole repairs throughout the county. It was confirmed that all archiving has now been transferred to Ipswich. Was advised of bank erosion on the roadside and water problems on the bend. Fallen trees on the roads are the Highways and landowners' responsibility. Thanks to Phillip and Glen for their help in keeping road open in floods clearing trees. Marc Allison flagged up the issues with Anglian Water destroying the Roadside Nature Reserve every time they work on the mains.

Nick Clarke- Small report received via e mail, attached. They have no agreed budget figures yet.

Meeting then closed and moved on to the PC meeting.

Councillors confirmed that they had no pecuniary or non-pecuniary interests in items on the agenda.

- 1. Minutes of our last meeting held on 6th September 2023. These were unanimously accepted as being in order. Copies were signed by Chairman.
- Matters arising from minutes. Require a team to run Speedwatch. A minimum of 7 people are required – typically 3 at any one time. Volunteers to be recruited via Facebook or Parish Pump magazine for interested parishioners. Martin to coordinate. The 20s plenty initiative. We are linked in with Stansfield. Asset of Community Value (ACV) for Allotments. The application is to be re-written and submitted. This will be led by Annie

Jones with support from Martin England and Marc Allison.

Grass cutting around village. We need an alternative quote. No recent communication from TOPS and they have not submitted any invoices for work done in 2023/24.

3. Financial Reports

(a). Accounts to 31st December prepared. All in order. Current balance is £8915.81, and this compares favourably with previous year (however no payment made to TOPS).(b). Agreed to donate to SARS of £50 and to reimburse June for £25 (wreath cost for Remembrance Sunday).

(c). A budget had been prepared which had been circulated, showing our position to date and estimate costs to 31 March 2024. At year end we should have approx. £6463 in our coffers. If we increase our share of the precept marginally (5.33 %) the cost for a Band D property would increase by £2.36 a year. Since there was no increase in the precept last year, it was felt this was acceptable and was signed off by chair and clerk. The completed form submitted to West Suffolk District Council 17 January 2024.

- 4. Grass Cutting-as above. TOPS to clear brambles from graves in the LHS of Parish Cemetery.
- 5. Query about a purchasing a security certificate for our website. This expenditure was approved and a one-off cost of £39 to be paid to OneSuffolk.
- 6. Councillors' Comments. Gravel on highway caused by rain. It is the District Council responsibility to clear storm drains. However, highways are the responsibility of Suffolk County Council. There is a problem with an overflowing ditch between Wentford Cottages and Long Acre. Martin England and Annie Jones to ascertain ownership since the landowner needs to clear ditch.
